

TEMPORARY RESOLUTION NO. 188-13

PERMANENT RESOLUTION NO. 182-13

A RESOLUTION TO REDUCE APPROPRIATION BUDGETS THEN AMEND THE CERTIFICATE OF APPROPRIATIONS WITH THE COUNTY AUDITOR AND COMPLETE A FUND TO FUND TRANSFER

WHEREAS, The 2013 Expense Budgets must be brought in line as to not exceed the actual cash on hand by December 31, 2013, which is monitored by the State Auditors. The City of Lancaster also must report any revenue and expense budget changes to the County Auditor due to the County Auditor keeping a record of the City's Revenue Budget Estimates and Expense Budgets. The City Auditor's records must match the County Auditor's records at the end of the year.

WHEREAS, A Fund to Fund Transfer needs to be completed to move the .15 Fire Levy Income Tax monies (352) from the Improvement Fund (317) into the newly created .15 Fire Levy Fund (246) to keep those monies separate per ORC 5708.09 (D).

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO
