

TEMPORARY ORDINANCE NO. 1-11

PERMANENT ORDINANCE NO. 2-11

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF LANCASTER, OHIO

WHEREAS, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Lancaster, Ohio;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Lancaster, State of Ohio.

SECTION 1. That the editing, arrangement and numbering of those ordinances and resolutions enacted by Council from December 31, 2009 through December 31, 2010, as listed in the Comparative Section Table, are hereby approved and adopted as printed in the 2010 Replacement Pages to the Codified Ordinances so as to achieve uniformity of style and classification.


