

TEMPORARY ORDINANCE NO. 29-11

PERMANENT ORDINANCE NO. 28-11

AN ORDINANCE TO ESTABLISH THE COMPENSATION FOR ELECTED OFFICIALS INCLUDING THE MAYOR, THE AUDITOR, AND TO MAINTAIN A FULL TIME LAW DIRECTOR FOR THE TERM COMMENCING JANUARY 1, 2012

WHEREAS, the City desires and intends to maintain a full time Law Director who will not engage in the private practice of law; and,

WHEREAS, the City intends to provide an office in the City Annex Building for the Law Director, Senior Attorney, Assistant Prosecutors and staff;

BE IT ORDAINED by the Council of the City of Lancaster, Fairfield County, State of Ohio

SECTION 1. That the compensation for the Mayor for the term commencing January 1, 2012, and ending December 31, 2015, shall be as follows:

Commencing January 1, 2012.....	\$86,327.00
Commencing January 1, 2013.....	\$86,327.00
Commencing January 1, 2014.....	\$86,327.00
Commencing January 1, 2015.....	\$86,327.00

SECTION 2. That the compensation for the Auditor for the term commencing January 1, 2012, and ending December 31, 2015, shall be as follows:

Commencing January 1, 2012.....	\$74,373.00
Commencing January 1, 2013.....	\$74,373.00
Commencing January 1, 2014.....	\$74,373.00
Commencing January 1, 2015.....	\$74,373.00

SECTION 3. That there be and hereby is provided a full time position for Law Director of the City of Lancaster, with offices at the City Annex Building.

SECTION 4. It is the intention of the City Council that the Law Director be full time and not maintain a private practice.

SECTION 5. That the compensation for the Law Director for the term commencing January 1, 2012, and ending December 31, 2015, shall be as follows:

Commencing January 1, 2012.....	\$99,638.00
Commencing January 1, 2013.....	\$99,638.00
Commencing January 1, 2014.....	\$99,638.00
Commencing January 1, 2015.....	\$99,638.00

SECTION 6. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
