A RESOLUTION TO ACCEPT, APPROPRIATE AND TRANSFER FUNDS FY 2012 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2012 Community Development Block Grant (CDBG) Grant Agreement and funding approval in the amount of \$435,542, for the program year commencing September 1, 2012, and

WHEREAS, program income from the repayment of housing rehabilitation loans and/or acquisition assistance loans in the amount of \$8,458 is available to be transferred and appropriated to the FY 2012 Private Housing Rehabilitation Account and/or FY 2012 Acquisition Assistance Account.

WHEREAS, it is necessary that said CDBG funds be accepted, appropriated, and transferred in accordance with the approved and authorized FY 2012 program; now, therefore

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. That the City of Lancaster's FY 2012 Community Development Block Grant in the amount of Four Hundred Thirty Five Thousand Five Hundred Forty Two Dollars (\$435,542) is hereby accepted.

SECTION 2. That the above grant (\$435,542) and program income (\$8,458) are hereby appropriated as follows, in accordance with the FY 2012 CDBG Annual Action Plan as authorized by Council per Permanent Resolution No. 101-12.
