A RESOLUTION TO CREATE A NEW FUND FOR SAFER GRANT (245)

WHEREAS, the City of Lancaster will receive the SAFER Grant, which is a reimbursement grant, which will allow the City to hire/bring back four firefighters;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. That the City of Lancaster Auditor establish a new fund for the SAFER Grant (Fund 245) and create expense accounts:

245.353.5102 (Salaries)  
245.353.5152 (Health Insurance)  
245.353.5153 (Medicare)  
245.353.5156 (Fire Pension – Employer)  
245.353.5157 (Fire Pension – Pickup)

SECTION 2. That the City of Lancaster Auditor amend the Certificate of Other Resources and Appropriation with the County Auditor by giving them this newly established SAFER Grant Fund (245).

SECTION 3. That the City of Lancaster Auditor amend the Certificate of Appropriations and Other Sources with the County Auditor in the amount of One Hundred Eighty Two Thousand Six Hundred Dollars (\$182,600.00) in the SAFER Grant Fund (245).

SECTION 4. That the City of Lancaster Auditor increase receipts in revenue account 245.000.4313 (Federal Grant) for the amount of One Hundred Eighty Two Thousand Six Hundred Dollars (\$182,600.00).

SECTION 5. That the City of Lancaster Auditor appropriate from the unencumbered balance in the SAFER Grant Fund (245) for the amount of One Hundred Eighty Two Thousand Six Hundred Dollars (\$182,600.00) into the following expense accounts:
