

TEMPORARY ORDINANCE NO. 5-15

PERMANENT ORDINANCE NO. 5-15

AN ORDINANCE TO AUTHORIZE THE ACCEPTANCE OF ONE AND EIGHT HUNDRED SIXTY-THREE THOUSANDTHS (1.863) ACRES, MORE OR LESS, OF PROPERTY SITUATED IN TOWNSHIP 14, RANGE 18, SECTION 7 FROM BIRCH REALTY, LTD. FOR THE CONSTRUCTION OF A SANITARY SEWER

WHEREAS, the City is undertaking a public improvement project known as the South Broad Street Express Sewer Project; and

WHEREAS, a sewer to be constructed as part of said improvement project must travel through said property; and

WHEREAS, Birch Realty, LTD. preferred to sell said property rather than grant an easement for the sewer;

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO:

SECTION 1. That the City hereby accepts one and eight hundred sixty-three thousandths (1.863) acres, more or less, of property situated in Township 14, Range 18, Section 7 from Birch Realty LTD., as further described in Exhibit A.

SECTION 2. That a real and present emergency exists and that this ordinance shall take effect and be in force from and after the earliest period allowed by law.

EXHIBIT A

Situated in the State of Ohio, Fairfield County, Township 14, Range 18, Section 7, City of Lancaster.

Being part of the 3.274 acres tract described in a deed to Westerman Inc. as recorded in Deed Volume 519, Page 282, and being more fully described as follows:

Beginning at the intersection of the east line of Columbus Street with the south line of the Hocking Canal, said point is located South 09 degrees 38' 35" East a distance of 125.36 feet from the intersection of the east line of Columbus Street with the south line of a 15 foot wide alley as shown on the plat of Giesy's Addition and recorded in Deed Book 11, Page 97;

Thence South 66 degrees 58' 13" East a distance of 7.10 feet to an angle in the line of the canal property, said point being South 06 degrees 57' 41" West a distance of 25.00 feet from a 5/8 inch rebar set at canal transit station 490+32.8;

Thence North 86 degrees 21' 30" East a distance of 245.90 feet to a one inch steel pin found at an angle point in the south line of Canal Street (66 foot right-of-way);

Thence with the south line of Canal Street and the Hocking Canal, North 86 degrees 00' 40" East a distance of 624.14 feet to a 5/8 inch rebar set;

Thence South 00 degrees 13' 10" West, passing a 5/8 inch rebar set at 71.67 feet, a distance of 171.67 feet to the center of the Hocking River and the north line of a 7.32 acre tract described in Deed Volume 530, Page 484;

Thence North 83 degrees 39' 41" West a distance of 876.10 feet to a point on the east line of Columbus Street;

Thence North 09 degrees 38' 35" West a distance of 18.95 feet to the point of beginning, **containing 1.863 acres.**

Bearings are based on an assumed meridian and are used for denoting angles only. Rebars set are 5/8 inch by 36 inches and have a yellow plastic identification cap labeled "Tobin-McFarland". For additional information see plat of survey made in conjunction with and considered an integral part of this description.

Description is based on a survey made in November of 1996 by Tobin-McFarland Surveying Inc. and was prepared by Rodney McFarland, Registered Professional Surveyor No. 6416.
