A RESOLUTION TO ACCEPT AND APPROPRIATE FUNDS FOR THE FY 2015 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2015 Community Development Block Grant (CDBG) Grant Agreement and funding approval in the amount of Four Hundred Fifty-Four Thousand Six Hundred Ninety Eight Dollars (\$454,698.00) for the program year commencing September 1, 2015, and

WHEREAS, it is necessary that said CDBG funds be accepted and appropriated in accordance with the approved and authorized FY 2015 program;
