A RESOLUTION TO INCREASE RECEIPTS, APPROPRIATE FROM THE UNENCUMBERED BALANCE AND AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS (273, 274, 275, 283, & 284)

WHEREAS, this legislation piece is to establish a beginning of the year revenue and expense budgets for all of the CDBG Funds, so that they can receive and expend CDBG grant funds;
