A FINAL RESOLUTION AUTHORIZING THE MAYOR OR SERVICE-SAFETY DIRECTOR TO ENTER INTO A CONTRACT WITH ODOT FOR WORK RELATING TO PROJECT FAI-SR-188-16.02

WHEREAS, on the 9th day of January, 2017, the Legislative Authority of the City of Lancaster, Ohio or local Public Agency (hereinafter LPA) enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of resurfacing and related work on SR 188, lying within the City of Lancaster; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred (100%) of the entire cost of the improvement, less the amount of Federal-aid and State, including Toll Revenue Credit, funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration U.S. Department of Transportation.

In view of the fact the LPA's share of the project is now estimated in the amount of Five Thousand Six Hundred Forty-Four Dollars (\$5,644.00) less Toll Revenue Credit in the amount of Five Thousand Six Hundred Forty-Four Dollars (\$5,644.00) leaving a balance of Zero Dollars (\$0.00) therefore, the City will not be required to deposit any funds at this time. The LPA's ultimate share of the cost will be determined when final actual costs are allocations are determined.

WHEREAS, the Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of same to this legislative authority; and

WHEREAS, this legislative authority desires the Director of Transportation to proceed with the aforesaid highway improvement;

NOW THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION 2. That the LPA enter into a contract with the State, and that Mayor and/or Service-Safety Director be, and is hereby authorized to execute said contract for improving the described project.

SECTION 3. That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION 4. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
