

TEMPORARY RESOLUTION NO. 9-17

PERMANENT RESOLUTION NO. 16-17

A RESOLUTION TO APPROPRIATE FROM THE UNENCUMBERED BALANCE, AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR IN LDOT IMPROVEMENT FUND (314) & LDOT FUND (208), AUTHORIZE THE ISSUANCE OF A THEN AND NOW CERTIFICATE, AND INCREASE RECEIPTS IN LDOT IMPROVEMENT FUND (314)

WHEREAS, this legislation piece is to establish a beginning of the year revenue and expense budget for the LDOT Improvement Fund and appropriate improvement money within the LDOT Fund;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, OHIO

SECTION 1. That the City Auditor amend the Certificate of Other Sources with the County Auditor in the LDOT Improvement Fund (314) in the amount of Two Hundred Ten Thousand Dollars (\$210,000.00).

SECTION 2. That the City Auditor increase receipts in the following revenue accounts:

SECTION 3. That the City Auditor amend the Certificate of Appropriations with the County Auditor in the LDOT Improvement Fund (314) in the amount of Two Hundred Sixty Thousand Four Hundred Nine Dollars and Ninety-Seven Cents. (\$260,409.97).
