A RESOLUTION TO ACCEPT AND APPROPRIATE FUNDS FOR FY 2017 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2017 Community Development Block Grant (CDBG) Grant Agreement and funding approval in the amount of Four Hundred Thirty-One Thousand Nine Hundred Forty-Two Dollars (\$431,942.00); and

WHEREAS, it is necessary that said CDBG funds be accepted and appropriated in accordance with the approved and authorized FY 2017 program and program amendments;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the City of Lancaster's FY 2017 Community Development Block Grant in the amount of Four Hundred Thirty-One Thousand Nine Hundred Forty Two Dollars (\$431,942.00) is hereby accepted.

SECTION 2. That the above grant in the amount of Four Hundred Thirty-One Thousand Nine Hundred Forty Two Dollars (\$431,942.00) and program amendments in the amount of Twenty-Six Thousand Six Hundred Ninety-Eight Dollars (\$26,698.00) are appropriated as follows, in accordance with the FY 2017 CDBG Annual Action Plan as authorized by Council per Permanent Resolution No. 61-17.
