

TEMPORARY ORDINANCE NO. 37-17

PERMANENT ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE TO ESTABLISH THE COMPENSATION FOR PART-TIME ELECTED OFFICIALS INCLUDING TREASURER, COUNCIL PRESIDENT, COUNCIL MEMBERS, AND THE APPOINTED COUNCIL CLERK, FOR THE TERM COMMENCING JANUARY 1, 2018

BE IT ORDAINED by the Council of the City of Lancaster, Fairfield County, State of Ohio

SECTION 1. That the compensation for the elected City Treasurer for the term commencing January 1, 2018, and ending December 31, 2021, shall be as follows:

Commencing January 1, 2018.....\$20,000.00 annually, payable bi-weekly  
Commencing January 1, 2019..... \$20,000.00 annually, payable bi-weekly  
Commencing January 1, 2020.....\$20,000.00 annually, payable bi-weekly  
Commencing January 1, 2021.....\$20,000.00 annually, payable bi-weekly

SECTION 2. That the compensation for the elected President of Council, and Council Members for the term commencing January 1, 2018, and ending December 31, 2019, shall be as follows:

Commencing January 1, 2018.....\$9,400.00 annually, payable bi-weekly  
Commencing January 1, 2019.....\$9,400.00 annually, payable bi-weekly

SECTION 3. That the compensation for the appointed Clerk of Council for the term commencing January 1, 2018, and ending December 31, 2019, shall be as follows:

Commencing January 1, 2018.....\$10,000.00 annually, payable bi-weekly  
Commencing January 1, 2019.....\$10,000.00 annually, payable bi-weekly

SECTION 4. The part-time Treasurer shall receive medical insurance coverage pursuant to the same policies, terms and conditions as these benefits are provided to non-elected City management personnel as set forth in the annual Management Pay Ordinance of City Council, and participate in the Public Employees Retirement System pursuant to LCO Section 145.18 and the Ohio Revised Code.

SECTION 5. The part-time Council President and Council Members shall participate in the Public Employees Retirement System pursuant to LCO Section 145.18 and the Ohio Revised Code, but shall receive no other benefits or compensation other than as listed above.

SECTION 6. The part-time appointed Clerk shall receive no other benefits or compensation other than as listed above, and shall participate in the Public Employees Retirement System pursuant to Ohio Revised Code.

SECTION 7. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
