A RESOLUTION TO ACCEPT AND APPROPRIATE FUNDS FY 2019 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT ENTITLEMENT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2019 Community Development Block Grant (CDBG) Agreement and Five Year Consolidated Housing and Community Development Plan funding approval in the amount of Four Hundred Seventy-Eight Thousand Five Hundred Ten Dollars (\$478,510.00); and

WHEREAS, it is necessary that said CDBG funds be accepted and appropriated in accordance with the approved and authorized FY 2019 program;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the City of Lancaster's FY 2019 Community Development Block Grant in the amount of Four Hundred Seventy-Eight Thousand Five Hundred Ten Dollars (\$478,510.00) is hereby accepted.

That the above grant in the amount of Four Hundred Seventy-Eight Thousand Five Hundred Ten Dollars (\$478,510.00) and amendments in the amount of Twenty Thousand Five Hundred Eighty-Five Dollars and Forty Cents (\$20,585.40) are hereby appropriated as follows, in accordance with the City's FY 2019 Community Development Block Grant Program as authorized by Council per Permanent Resolution Number 74-19.
