

TEMPORARY ORDINANCE NO. 30-19

PERMANENT ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE TO ESTABLISH THE COMPENSATION FOR ELECTED OFFICIALS INCLUDING THE MAYOR, AUDITOR, COUNCIL PRESIDENT, COUNCIL MEMBERS, COUNCIL CLERK, AND TO MAINTAIN A FULL TIME LAW DIRECTOR FOR THE TERM COMMENCING PAYROLL 1 OF 2020

BE IT ORDAINED by the Council of the City of Lancaster, Fairfield County, State of Ohio

SECTION 1. That the compensation for the Mayor for the term commencing January 1, 2020, and ending December 31, 2023, shall be as follows:

Commencing January 1, 2020.....	\$ 97,161.13
Commencing January 1, 2021.....	\$ 97,161.13
Commencing January 1, 2022.....	\$ 99,104.35
Commencing January 1, 2023.....	\$101,086.43

SECTION 2. That the compensation for the Auditor for the term commencing January 1, 2020, and ending December 31, 2023, shall be as follows:

Commencing January 1, 2020.....	\$83,707.22
Commencing January 1, 2021.....	\$83,707.22
Commencing January 1, 2022.....	\$85,381.36
Commencing January 1, 2023.....	\$87,088.98

SECTION 3. That the compensation for the President of Council, and Council Persons for the term commencing January 1, 2020, and ending December 31, 2021, shall be as follows:

Commencing January 1, 2020.....	\$9,400.00
Commencing January 1, 2021.....	\$9,400.00

SECTION 4. That the compensation for the Clerk of Council for the term commencing January 1, 2020, and ending December 31, 2021, shall be as follows:

Commencing January 1, 2020.....	\$10,000.00
Commencing January 1, 2021.....	\$10,000.00

SECTION 5. That there be and hereby is provided a full time position for Law Director of the City of Lancaster.

SECTION 6. It is the intention of the City Council that the Law Director be full time and not maintain a private practice.

SECTION 7. That the compensation for the Law Director for the term commencing January 1, 2020, and ending December 31, 2023, shall be as follows:

Commencing January 1, 2020.....	\$112,143.38
Commencing January 1, 2021.....	\$112,143.38
Commencing January 1, 2022.....	\$114,386.24
Commencing January 1, 2023.....	\$116,673.96

SECTION 8. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
