PERMANENT RESOLUTION NO. 133-19

A RESOLUTION TO CREATE A NEW FUND FOR BWC PROCESSING (850) AND TO SET UP REVENUE AND EXPENSE ACCOUNTS

WHEREAS, the Bureau of Workers Compensation (BWC) changed their billing process to "Prospective Billing" a couple of years back which made the City's management of the billing and payments more complex; and

WHEREAS, a new Fund for the BWC Processing needs to be established to contain the flow of monthly billing payments and monthly departmental payments to reimburse the BWC Processing Fund; and

WHEREAS, the expense accounts are needed to track the actual payments made to BWC and all refund payments made back to departments from any BWC refunds throughout the year;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the City of Lancaster Auditor establish a new fund for the BWC Processing (Fund 850) and create the following revenue and expense accounts:
