A RESOLUTION TO ACCEPT AND ALLOCATE FUNDS FY 2020 CITY OF LANCASTER COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the City of Lancaster has received its FY 2020 Community Development Block Grant (CDBG) Agreement and funding approval in the amount of Five Hundred Four Thousand Four Hundred Sixty-One Dollars (\$504,461.00); and

WHEREAS, it is necessary that said CDBG funds be accepted and allocated in accordance with the approved and authorized FY 2020 program;

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the City of Lancaster's FY 2020 Community Development Block Grant in the amount of Five Hundred Four Thousand Four Hundred Sixty-One Dollars (\$504,461.00) is hereby accepted.

That the above grant in the amount of Five Hundred Four Thousand Four Hundred Sixty-One Dollars (\$504,461.00) and amendments in the amount of Thirteen Thousand Four Hundred Eighty-Two Dollars and Twenty Two Cents (\$13,482.22) are hereby allocated as follows, in accordance by Council per Permanent Resolution Number 84-20.
