A RESOLUTION APPROVING AND AUTHORIZING THE MAYOR TO SUBMIT TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT LANCASTER'S FISCAL YEAR (FY) 2021 COMMUNITY DEVELOPMENT BLOCK GRANT ANNUAL ACTION PLAN AND STATEMENT OF OBJECTIVES

WHEREAS, the City of Lancaster anticipates receiving an entitlement allocation of Five Hundred Eleven Thousand Six Hundred Seven Dollars (\$511,607.00) in FY 2021 Community Development Block Grant (CDBG) funding; and

WHEREAS, the City has prepared its FY 2021 Annual Action Plan to be consistent with the City's Consolidated Housing and Community Development Plan FY 2018 – FY 2022 which identifies housing and non-housing community development needs; and

WHEREAS, the FY 2021 Annual Action Plan has been developed in accordance with Lancaster's Citizen Participation Plan, including two public hearings conducted on March 30, 2021, and June 14, 2021, along with a publication of an executive summary and a summary of the proposed Annual Action Plan for public comments;

SECTION 1. The FY 2021 CDBG Annual Action Plan and Statement of Objectives/Use of Funds are hereby approved and incorporated herein by reference as follows:
