A RESOLUTION AUTHORIZING THE SERVICE-SAFETY DIRECTOR TO DISPENSE WITH COMPETITIVE BIDDING PURSUANT TO THE ~~MASTER INTERGOVERNMENTAL COOPERATIVE PURCHASE AGREEMENT ADMINISTERED BY OMNIA PARTNERS, PUBLIC SECTOR~~ **AUTHORITY GRANTED TO REGIONAL COUNCILS OF GOVERNMENTS IN OHIO REVISED CODE TITLE ONE CHAPTER 167 SECTION 167.081** FOR THE PURCHASE OF ROOFING MATERIALS AND SERVICES AND TO APPROPRIATE FROM THE UNENCUMBERED BALANCE AND AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR IN THE WASTEWATER FUND (6004)

~~WHEREAS, purchases from the Master Intergovernmental Cooperative Purchasing Agreement (MICPA) are exempt from public bid requirements under ORC Section 9.48 (B)(2); and~~

~~WHEREAS, the provided roofing materials and services will be used to repair and re-roof the City of Lancaster's Water Pollution Control Department Secondary Control Building;~~

**WHEREAS, pursuant to Ohio Revised Code 167.081, regional councils of governments are authorized to contract for the acquisition of materials and labor and for the performance of construction projects on behalf of their members; and**

**WHEREAS, regional councils of government have the statutory ability to piggyback onto existing joint cooperative purchasing agreements as long as they were awarded with competitive bidding; and**

**WHEREAS, the City is a member of the Mid-Ohio Regional Planning Commission (MORPC), a regional council of governments that contracts for provision of goods and services through the Master Intergovernmental Cooperative Purchasing Agreement (MICPA), a joint cooperative purchasing agreement administered by OMNIA Partners; and**

**WHEREAS, the MICPA was competitively bid and includes terms for the procurement of roofing materials and services which the City will use to repair and re-roof the City's Water Pollution Control Department Secondary Control Building;**

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the Service-Safety Director is hereby authorized to dispense with competitive bidding under ~~the MICPA~~ **ORC Section 167.081** for the provision of roofing materials and supplies necessary to perform the work required on the City of Lancaster's Water Pollution Control Department Secondary Control Building.

SECTION 2. That the City of Lancaster Auditor amend the Certificate of Appropriations with the County Auditor in the amount of One Hundred Sixty Thousand Dollars (\$160,000.00) in the Wastewater Fund (6004).

SECTION 3. That the City of Lancaster Auditor appropriate from the unencumbered balance in the amount of One Hundred Sixty Thousand Dollars (\$160,000.00) into expense account 6004.6750.56004 (WPC Improvements).

SECTION 4. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
