PERMANENT RESOLUTION NO. 43-22

A RESOLUTION TO INCREASE RECEIPTS, APPROPRIATE FROM THE UNENCUMBERED BALANCE, AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR, AND COMPLETE AN INCREASE AND DECREASE IN THE .45 POLICE & FIRE LEVY FUND (2047) AND AN INCREASE AND DECREASE IN THE .45 POLICE & FIRE LEVY 2021 FUND (2051)

WHEREAS, the City of Lancaster Police Department received a 2022 Continuing Professional Training – CPT State Grant from Ohio Attorney General Dave Yost’s Office in the amount of Twenty-Seven Thousand Seven Hundred Sixty Dollars and Fifty-Six Cents (\$27,760.56); and

WHEREAS, the CPT Update Bulletin CPT2022-01 mandate requires every peace officer and trooper in Ohio to complete 24 hours of training this calendar year; and

WHEREAS, the CPT State Grant funds are to subsidize officers’ salaries while they complete the required 24 hours of training; and

WHEREAS, the Lancaster City Auditor will reimburse the salary account from which officers were paid their regular bi-weekly wages for CPT training time with funds from the Police CPT Training Salaries account, which will allow the additional unspent salary appropriations to be moved into the officer training accounts to offset the required training cost; and

WHEREAS, the Lancaster Police Department needs to complete a budget transfer from its officer salary accounts into its officer training accounts to be able to facilitate the CPT required training (percentage split out of grant dollars 49.07% Fund 2047 and 50.93% Fund 2051);

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO,

SECTION 1. That the City of Lancaster Auditor amend the Certificate of Other Sources and Appropriations with the County Auditor in the amount of Twenty-Seven Thousand Seven Hundred Sixty Dollars and Fifty-Six Cents (\$27,760.56) in the .45 Police & Fire Levy Fund (2047).
