PERMANENT RESOLUTION NO. 103-22

A RESOLUTION TO APPROPRIATE FROM THE UNENCUMBERED BALANCE AND AMEND THE CERTIFICATE OF APPROPRIATIONS WITH THE COUNTY AUDITOR IN THE GENERAL FUND (1001); INCREASE RECEIPTS, APPROPRIATE FROM THE UNENCUMBERED BALANCE, AND AMEND THE CERTIFICATE OF OTHER SOURCES AND APPROPRIATIONS WITH THE COUNTY AUDITOR IN THE LANCASTER COMMUNITY DEVELOPMENT FUND (2026)

WHEREAS, the City of Lancaster received a grant from the U.S. Department of Housing and Urban Development (HUD) Healthy Homes Production Program in the amount of One Million Dollars (\$1,000,000.00); and

WHEREAS, these grant funds will be used to remediate health hazards in the residences of low income homeowners and renters in the City of Lancaster; and

WHEREAS, the Healthy Homes Production Program is a monthly reimbursement grant and CDBG is requesting a Fifty Thousand Dollars (\$50,000.00) advance from the General Fund as a startup for cash to pay for expenses which will then be reimbursed by HUD; and

WHEREAS, this Fifty Thousand Dollars (\$50,000.00) advance from the General Fund will then be reimbursed once all expenses have been reimbursed by the grant;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO,

SECTION 1. That the City of Lancaster Auditor appropriate from the unencumbered balance in expense account 1001.9900.59046 (Tran/Comm. Dev) in the amount of Fifty Thousand Dollars (\$50,000.00).

SECTION 2. That the City of Lancaster Auditor amend the Certificate Appropriations with the County Auditor in the amount of Fifty Thousand Dollars (\$50,000.00) in the General Fund (1001).

SECTION 3. That the City of Lancaster Auditor increase receipts in revenue account 2026.8032.49086 (Transfer/General Fund Health Homes) in the amount of Fifty Thousand Dollars (\$50,000.00).

SECTION 4. That the City of Lancaster Auditor amend the Certificate of Other Sources and Appropriations with the County Auditor in the amount of Fifty Thousand Dollars (\$50,000.00) in the Lancaster Community Development Fund (2026).

SECTION 5. That the City of Lancaster Auditor appropriate from the unencumbered balance in expense account 2026.8032.52034 (Contract Services Healthy Home Fed Grant) in the amount of Fifty Thousand Dollars (\$50,000.00).

SECTION 6. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
