PERMANENT RESOLUTION NO. 136-22

A RESOLUTION TO INCREASE AND DECREASE APPROPRIATIONS IN THE DEPARTMENT OF JUSTICE (DOJ) EQUITABLE SHARING FUND (2048) FOR THE PURCHASE OF ONE NEW CRUISER FOR LANCASTER POLICE DEPARTMENT

WHEREAS, currently, there is an unprecedented one-year delay on receiving police cruisers from Ford; and

WHEREAS, the Lancaster Police Department (LPD) has located police cruisers in stock at Kenny Ross Ford in Pennsylvania; and

WHEREAS, in order to have a police cruiser ready for LPD's first Directed Patrol Unit / K9 as soon as possible, LPD would prefer to purchase this vehicle immediately to avoid the extended delay; and

WHEREAS, the funds for this purchase are available as the result of seizures from investigations LPD participated in with the Drug Enforcement Agency (DEA) and Major Crimes Unit (MCU) and all MCU board members have approved the usage of these funds for this purpose; and

WHEREAS, the funds are currently in a fiduciary account that LPD controls with MCU (2048) and will just need to be moved to make this purchase possible;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO,
