A RESOLUTION AUTHORIZING THE SERVICE-SAFETY DIRECTOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT WITH A QUALIFIED CONTRACTOR FOR THE PROJECT KNOWN AS THE 2023 STREET IMPROVEMENT PAVING PROGRAM

WHEREAS, the Lancaster Department of Transportation and City Engineer are currently planning for the 2023 Street Improvement Paving Program, **which will include resurfacing projects funded by both 3 Mill Levy Funds and appropriations in the Parks Department;** and

WHEREAS, the scope of the anticipated resurfacing **from 3 Mill Levy Funds** is attached hereto as "Exhibit A"; and

WHEREAS, this **portion of the paving program (Exhibit A)** is expected to cost approximately One Million Seven Hundred Thousand Dollars (\$1,700,000.00); and

WHEREAS, the Parks Board has authorized the City Engineer to include Rising Park resurfacing in the 2023 Street Improvement Paving Program and the scope of that resurfacing is attached hereto as "Exhibit B"; and

WHEREAS, this portion of the paving program (Exhibit B) is expected to cost approximately Four Hundred Sixty-Eight Thousand Dollars (\$468,000.00);

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the Service-Safety Director is hereby authorized to advertise for bids and enter into a contract with a qualified contractor for the project known as the 2023 Street Improvement Paving Program in an amount not to exceed **Two Million One Hundred Sixty-Eight Thousand Dollars (\$2,168,000.00)** ~~One Million Seven Hundred Thousand Dollars (\$1,700,000.00)~~.

SECTION 2. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
