A RESOLUTION AUTHORIZING THE SERVICE-SAFETY DIRECTOR TO ADVERTISE FOR BIDS AND ENTER INTO A CONTRACT WITH A QUALIFIED CONSULTANT FOR INSPECTION SERVICES FOR THE 2024 STREET IMPROVEMENT PROGRAM

WHEREAS, the Lancaster Department of Transportation and City Engineer are currently planning for paving during the 2024 Street Improvement Program; and

WHEREAS, inspection services are required to ensure that this paving project is delivered to the City Engineer's standards; and

WHEREAS, these services are expected to cost approximately One Million Eight Hundred Thousand Dollars (\$1,800,000.00) and will be funded by the 3 Mill Levy Funds from the 2009 Account; now, therefore,

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO

SECTION 1. That the Service-Safety Director is hereby authorized to advertise for bids and enter into a contract with a qualified consultant for inspection services on the project known as the 2024 Street Improvement Program - Paving in an amount not to exceed One Million Eight Hundred Thousand Dollars (\$1,800,000.00).

SECTION 2. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
