PERMANENT RESOLUTION NO. 120-23

A RESOLUTION TO INCREASE AND DECREASE APPROPRIATIONS IN THE MUNI CT/JUDICIAL/DRUG CT/ADAMH FUND (2039) AND TO DECLARE AN EMERGENCY

WHEREAS, the new Veterans' Court Grant requires that its funds be tracked separately from current accounts; and

WHEREAS, since it is a reimbursable grant, the Court is requesting funds be transferred from other line items to cover the start-up costs for the probation officer position paid for by this grant; and

WHEREAS, the probation officer for Veterans' Court was already hired on November 13, 2023, in anticipation of transferring funds to pay for that position's salary and benefits; now, therefore,
