

TEMPORARY ORDINANCE NO. 1-24

PERMANENT ORDINANCE NO. _____

AN ORDINANCE TO RELEASE AN EASEMENT FOR PIPELINE K-221 ON FAIRFIELD COUNTY TAX PARCEL NUMBER 0535031610 AND TO DECLARE AN EMERGENCY

WHEREAS, on January 13, 2005, Columbia Gas Transmission Corporation conveyed to the City of Lancaster an abandoned six (6) inch pipeline known as "K-221" that previously served the S. Ewing Street Anchor Hocking plant; and

WHEREAS, Lancaster Municipal Gas has no need for Pipeline K-221, its facilities, or the underlying easement and land rights on Fairfield County Tax Parcel No. 0535031610; and

WHEREAS, LDG Development has a contract to purchase Parcel No. 0535031610 from the current owner and is in the underwriting process to construct a multi-family residential development thereon; and

WHEREAS, LDG Development has requested that the easement for decommissioned pipeline K-221 on Parcel No. 0535031610 be released to satisfy the Ohio Housing Finance Authority ("OHFA") and other potential underwriters; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO,

SECTION 1. That the Mayor is hereby authorized to enter into a Partial Release of Easement with the current property owner exclusively for the portion of Pipeline K-221 which runs over, through, under, and across Parcel No. 0535031610 and to execute all documents necessary to complete said Partial Release of Easement.

SECTION 2. The Partial Release of Easement (Exhibit 1 – attached hereto) in the form presently on file with the Clerk of Council is hereby approved and authorized with changes therein not inconsistent with this Ordinance and not substantially adverse to the City. This Council further authorizes the Mayor for and in the name of the City, to execute any amendments or changes to the final documents, which amendments are not inconsistent with this Ordinance and not substantially adverse to the City.

SECTION 3. That this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the City and for the further reason that this ordinance needs to be enacted for the developer to certify to OHFA that the City's easement and underlying property rights have been released; wherefore, this ordinance shall take effect and be in force immediately upon its adoption and approval by the Mayor.

BILL OF SALE AND ASSIGNMENT

THIS BILL OF SALE AND ASSIGNMENT, made and entered into this 15th day of November, 2005, by and between COLUMBIA GAS TRANSMISSION CORPORATION, a Delaware corporation, having an address of 1700 MacCorkle Avenue, SE, Charleston, West Virginia, hereinafter referred to as "COLUMBIA", and CITY OF LANCASTER, having an address 1424 Camp Ground Road, Lancaster, Ohio 43130-9503, hereinafter referred to as "CITY".

WHEREAS, COLUMBIA and CITY entered into a certain Purchase and Sale Agreement dated December 23, 2004 (hereinafter "PSA"), whereby COLUMBIA agreed to sell to CITY, and CITY agreed to buy from COLUMBIA, four (4) inch pipeline and related land rights, known as Pipeline K-221; and *SIX (6) ft*

WHEREAS, by this Bill of Sale and Assignment, the parties intend to consummate the sale as provided by the aforesaid Purchase and Sale Agreement;

NOW, THEREFORE, WITNESSETH; THAT, for and in consideration of the sum of One Dollar (\$1.00) and for other good and valuable considerations, the receipt and sufficiency of which is hereby acknowledged, COLUMBIA does hereby SELL, GRANT, CONVEY, ASSIGN, RELEASE and TRANSFER to CITY, its successors and assigns, all of COLUMBIA's right, title and interest in and to the following assets and real property interests situate in Fairfield County, Ohio, known as Pipeline K-221, to wit:

- (a) all of COLUMBIA's existing pipeline facilities identified on Exhibit A attached hereto and made a part hereof; and
- (b) all of COLUMBIA's rights, title and interest in the right-of-way agreement or other interests in property relating thereto, subject to the limitations, if any, contained in such documents of title, assignment or other documents identified in Exhibit B attached hereto and made a part hereof; and
- (c) all of COLUMBIA's rights, title and interest in the lease agreements or other interests in property relating thereto, subject to the limitations, if any, contained in such documents of title, assignment or other documents, identified on Exhibit C attached hereto and made a part hereof.

TO HAVE AND TO HOLD all and singular the assets and property rights hereby sold, assigned, transferred, set-over and delivered unto CITY its successors and assigns.

UNLESS OTHERWISE SET FORTH IN THE PSA, THE ASSETS BEING SOLD AND TRANSFERRED HEREIN ARE BEING SOLD AND TRANSFERRED ON AN "AS IS" BASIS, WITHOUT ANY EXPRESS OR IMPLIED WARRANTY OF TITLE, QUALITY, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER WARRANTY OF ANY KIND WHATSOEVER.

Effective as of the date of Bill of Sale and Assignment, CITY agrees to perform and observe all the conditions contained in the right-of-way and/or lease agreements transferred herein and assumes and agrees to pay all taxes associated with said property rights sold herein, if any.

COLUMBIA hereby covenants and agrees with CITY, its successors and assigns, to execute, acknowledge and deliver all and every such further assignments and other instruments as may be necessary to more fully assure CITY, its successors and assigns, all interests and rights herein sold, assigned, transferred, set over and delivered.

This conveyance is subject to all covenants, restrictions, conditions, reservations, rights of way and easements contained of record in the Land Records of Meigs County, Ohio.







PARTIAL RELEASE OF EASEMENT

This PARTIAL RELEASE OF EASEMENT, hereinafter referred to as “Release” is made and entered into this ___ day of _____ 2024, by and between the City of Lancaster, Ohio, a municipal corporation formed under the laws of the State of Ohio and whose mailing address is 104 E. Main Street, Lancaster, Ohio 43130, hereinafter referred to as “CITY”, and Gandee Precision Machine, the listed property owner, and having an address of PO Box 235, Lancaster, Ohio, 43130, hereinafter referred to as “GRANTEE”.

WHEREAS, CITY obtained a six (6) inch steel gas pipeline, known as “Pipeline K-221” as well as pipeline facilities and related land rights across multiple parcels from the Columbia Gas Transmission Corporation, by way of Assignment, on or about January 13, 2005 (Exhibit A);

WHEREAS, a decommissioned portion of Pipeline K-221 lies under Fairfield County Auditor Parcel Number 0535031610, otherwise known as 730 S. Ewing Street, Lancaster, Ohio, 43130, hereinafter referred to as “the Property” (Exhibit B) (Exhibit C); and

WHEREAS, it is mutually beneficial to the parties that CITY release the decommissioned portion of Pipeline K-221 which lies under the Property, along with its pipeline facilities and related land rights to GRANTEE; and

NOW, THEREFORE, for adequate consideration received, the sufficiency of which is hereby acknowledged, CITY and GRANTEE hereby agree as follows:

Section 1. Partial Release of Easement. CITY hereby releases its easement, facilities, and land rights to Pipeline K-221 located on the Property. CITY only releases its easement, facilities, and land rights to Pipeline K-221 under the Property; the City is not releasing any other easements, facilities, and/or land rights to any other property or parcel.

Section 2. Ownership. GRANTEE acknowledges that he or she is the lawful owner of the Property and/or the lawful representative of the owner of the Property.

Section 3. Indemnity. GRANTEE agrees to indemnify, defend, and hold harmless CITY from, against, and in respect of any and all liability, claims, damages, costs, and losses of whatever character (collectively, “Claims”) arising from personal injury, death, or damage to property of GRANTEE, and any and all Claims of whatever character claimed by third parties, to the extent that such Claims result from the action, negligence, or willful misconduct of CITY, its employees, agents, contractors, and/or subcontractors in connection with this Agreement.
