PERMANENT RESOLUTION NO. 4-24

A RESOLUTION TO SET A 2024 REVENUE AND EXPENSE BUDGET IN THE WATER UTILITY RESERVE FUND (6019), AMEND THE CERTIFICATE WITH THE COUNTY AUDITOR, AND AUTHORIZE THEN AND NOW CERTIFICATES FOR PAYMENT OF BILLS

WHEREAS, unspent balances within the Stormwater Utility Reserve Fund (6019) need to be reappropriated; and

WHEREAS, a 2024 revenue budget needs to be established; now, therefore,

BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO,

SECTION 1. That the City of Lancaster Auditor amend the Certificate of Other Sources with the County Auditor in the Improvement Account 6019 Stormwater Utility Reserve in the amount of One Million Twenty Thousand Five Hundred Ninety-Eight Dollars (\$1,020,598.00).

SECTION 2. That the City of Lancaster Auditor amend the Certificate of Appropriations with the County Auditor in the Improvement Account 6019 Stormwater Utility Reserve in the amount of Three Million Nine Hundred Ninety-Six Thousand Three Hundred Thirteen Dollars and Ninety-Three Cents (\$3,996,313.93).

SECTION 3. That the City of Lancaster Auditor increase receipts in the Improvement Fund 6019 Stormwater Utility Reserve in the amount of \$1,020,598.00 as follows

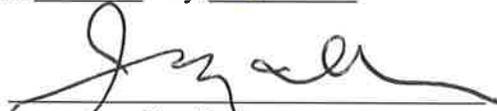

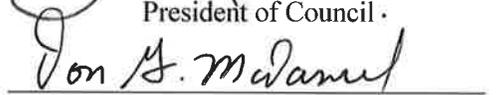
SECTION 6. That this resolution shall take effect and be in force from and after the earliest period allowed by law.
