BE IT RESOLVED BY COUNCIL OF THE CITY OF LANCASTER, STATE OF OHIO:

SECTION 1. That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

SECTION 2. That there shall be and is hereby levied on the tax duplicate of the **City of Lancaster** the rate of each tax necessary to be levied within and without the ten mill limitation as follows: See Exhibit A attached hereto and fully incorporated herein.
