PERMANENT ORDINANCE NO. 36-13

AN ORDINANCE TO AMEND LANCASTER CODIFIED ORDINANCE TITLE THREE – LEGISLATIVE, CHAPTER 111. RULES OF COUNCIL, SECTION 111.06, ENTITLED “STANDING COMMITTEES” AND TO REPEAL CURRENT LANCASTER CODIFIED ORDINANCE TITLE THREE – LEGISLATIVE, CHAPTER 111. RULES OF COUNCIL, SECTION 111.06, AND TO DECLARE AN EMERGENCY

BE IT ORDAINED by the Council of the City of Lancaster, State of Ohio

SECTION 1. That Lancaster Codified Ordinance Title Three – Legislative, Chapter 111. Rules of Council, Section 111.06, Entitled “Standing Committees,” be amended as follows:

111.06 STANDING COMMITTEES.

Standing committees shall be appointed by the President of Council, in open Council and the first named member of any committee shall be chairman. It shall be the duty of the President, not later than the first meeting of the new term, to appoint standing committees for the ensuing term on each of the following subjects:

- (a) Finance Committee.
(Auditor, Treasurer, **Income Tax**, and City Budget)
- (b) Safety Committee.
(Police and Fire ~~Department~~)
- (c) Services Committee.
(Utility Collection, ~~Income Tax~~, Gas, and Sanitation, and **IT/Telecom**
~~Engineering & Certified Building Departments~~)
- (d) Water/Water Pollution Control Committee.
(Water ~~Department~~, Waste Water ~~Treatment~~, and Storm Water ~~Utility~~)
- (e) Public Works Committee.
(~~Department of Transportation~~ **LDOT**, **Public Transit**, & Cemetery
~~Department~~)
- (f) Law Committee.
(General Legal Issues, Law Director’s Office, Municipal Court, and Clerk of Court, ~~Code Enforcement~~, and Council Clerk)
- (g) ~~Planning, Zoning &~~ **Economic Development**.
(~~Zoning Issues~~, CDBG Program; Annexations, Economic Development
~~Issues~~){~~bodies including the~~ **Economic Development related groups**
[Chamber of Commerce, CIC, etc. ~~and other~~]}

(h) Public Service Boards & Administration Committee.
(Parks & Recreation, Olivedale, Mayor's Office, and Service-Safety Director)



SECTION 2. That current Lancaster Codified Ordinance Title Three – Legislative, Chapter 111. Rules of Council, Section 111.06, are hereby repealed in its entirety.


