

TEMPORARY RESOLUTION NO. 16-13

PERMANENT RESOLUTION NO. 5 -13

A RESOLUTION TO SUBMIT TO THE FAIRFIELD COUNTY AUDITOR A REQUEST TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE CITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED FROM AN ADDITIONAL TAX OF 3 MILLS FOR THE PURPOSE OF PROVIDING FUNDS FOR THE GENERAL CONSTRUCTION, RECONSTRUCTION, RESURFACING AND REPAIR OF STREETS, ROADS AND BRIDGES IN THE CITY, AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the City of Lancaster, Ohio, two-thirds of all members elected thereto concurring, that:

Section 1. This Council determines that the amount of taxes which may be raised within the 10-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount necessary for the purpose of the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the City, and this Council further determines it is necessary to levy a tax in excess of such 10-mill limitation for such purpose.

Section 2. This Council intends to submit to the electors of the City at the election to be held on the May 7, 2013, the question of levying an additional tax of 3 mills for the purpose of the general construction, reconstruction, resurfacing and repair of streets, roads and bridges in the City.

Section 3. This Council, as the taxing authority for the City, pursuant to Ohio Revised Code Section 5705.03(B), requests that the Fairfield County Auditor certify to this Council the current total tax valuation of the City and the dollar amount that would be generated by an additional tax of 3 mills for the purpose of the general construction, reconstruction, resurfacing and repair of streets, roads and bridges pursuant to Ohio Revised Code Section 5705.19(G).

Section 4. The Clerk of this Council is directed to certify a copy of this resolution to the Fairfield County Auditor pursuant to the provisions of Ohio Revised Code Section 5705.03(B), and the Clerk is authorized to perform all actions necessary to accomplish the purpose of this resolution.


Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were taken in meetings open to the public in compliance with the law.

Section 6. This resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City and for the further reason that this resolution must be delivered to the Fairfield County Auditor in order to obtain the Fairfield County Auditor's certification of the

facts requested in this resolution for consideration by this Council in determining as to whether to submit the question of the additional tax to the electors on May 7, 2013; wherefore, this resolution shall take effect and be in force immediately upon its adoption and approval by the Mayor.
