A PRELIMINARY RESOLUTION FOR THE RESURFACING OF PORTIONS OF US 22, SR37, SR158, AND SR 188 WITHIN THE CITY OF LANCASTER UNDER THE ODOT URBAN PAVING PROGRAM REQUIRING MATCHING FUNDS FORM THE CITY ENACTED BY THE LANCASTER CITY COUNCIL FAIRFIELD COUNTY, OHIO, HEREINAFTER REFERRED TO AS THE LOCAL PUBLIC AGENCY, IN THE MATTER OF THE STATED DESCRIBED PROJECT, AND TO DECLARE AN EMERGENCY

SECTION I - Project Description

WHEREAS, the LPA/STATE has identified the need for the described project:

Resurfacing of portions of US 22, SR 37, SR 158 and SR 188 within the City of Lancaster under the ODOT Urban Paving Program requiring matching funds from the City.

NOW THEREFORE, be it ordained by the Lancaster City Council of Fairfield County, Ohio

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA agrees to pay One Hundred Percent (100%) of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the Project.

SECTION IV - Utilities and Right-of-Way Statement

The LPA agrees that all right-of-way required for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.

The LPA agrees that all utility accommodation, relocation and reimbursement will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

SECTION V - Maintenance

Upon completion of the Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the Project in accordance with all applicable state and federal law, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as

necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

SECTION VI This Resolution is hereby declared to be an emergency measure to expedite the highway project(s) and to promote highway safety. Following appropriate legislative action, it shall take effect and be in force immediately upon its passage and approval, otherwise it shall take effect and be in force from and after the earliest period allowed by law.

SECTION VII - Authority to Sign

The Service-Safety Director of said Lancaster City Council is hereby empowered on Michael J. Courtney, Service-Safety Director on behalf of the Lancaster City Council to enter into contracts with the Director of Transportation necessary to complete the above described project.
